Regular Monthly Meeting
November 11, 2024 at 6:00 pm

CALL TO ORDER: The annual Budget Hearing of the Exeland Village Board was called to order by Susan Kopras at 6:00 pm.

They will be returning next summer to start installing line in the village and he will tack on the small amount to their first bill. Deach requested a load of gravel for patching and filling holes. He also reported posting a sign at 871N Elm Park Drive in regard to water shut-off. A copy of the notice is attached to these minutes.
