Regular Monthly Meeting  
December 8, 2025 at 6:00 pm

**CALL TO ORDER:** The regular monthly meeting of the Exeland Village Board was called to order by Susan Kopras at 6:00 pm.

**PLEDGE OF ALLEGIANCE:** The Pledge of Allegiance was said by all present.

**ROLL CALL:** Present: Susan Kopras, Duane Mansky, Nicole Trott, Deb Fetting, Robert Deach.

**AGENDA PROPERLY POSTED:** Kopras certified the agenda was properly posted.

**APPROVE AGENDA:** A motion was made by Trott to approve the agenda. Mansky seconded the motion. Motion carried.

**APPROVE MINUTES OF PREVIOUS MEETING:** A motion was made by Mansky to approve minutes from November 10, 2025 Trott seconded the motion. Motion carried.

**APPROVE TREASURER'S REPORT:** Fetting gave Treasurer's report. A motion was made by Mansky to approve the Treasurer's report with correction of 12/8/25 general disbursements to \$24,542.41. Trott seconded the motion. Motion carried.

Kopras reported that the road ratings were completed and submitted to the DOT by Cliff Parr. No action taken.

**VOTING MACHINE UPDATE:**

Trott reported that the new voting machine was brought to the Village Hall following a training by Command Central in Hayward. The machine will not fit in the present cabinet. Space in the hallway was reviewed and Deach will build a new cabinet. No action taken.

Kopras reminded that the Village is scheduled to host the Sawyer County Towns Association meeting on January 26, 2026 at 7:00 p.m. We are responsible for supplying the lunch. No action taken.

Deach reported that he received a quote from McCarthy Well Company for the new meter and other equipment for the well house. The estimated total is \$8,375 which comes in under the budgeted amount. Deach also reported that the sanitary survey is being scheduled with Kira from the DNR.
